I am sorry about the delay in replying to you about this patient.

Firstly, I do not believe that she requires a repeat liver biopsy.

Her liver biopsy in 1995 showed an established cirrhosis and I reviewed this recently. There are some lymphocytes in the parenchyma with slight activity at the margins of the nodules so that she probably has a very mild continuing hepatitis.

The position is as I wrote to Frank Dunn last October. Interferon could be used but the chances of her clearing the virus given that she has cirrhosis must be around 20 to 25% only. This is after treatment three times a week for at least a year.

The other problem is that the Trust will not pay for this treatment. I have learned that the Greater Glasgow Health Board has given money to two centres at the Royal Infirmary and the Western Infirmary to treat a number of patients. I have been in touch with John Morris there who is a new Consultant Gastroenterologist and he is running the service. He has indicated his willingness to see any patients from Stobhill who are hepatitis C positive and to consider them for Interferon. He may for the purposes of his study require further liver biopsy.
